MEDIA ACCREDITATION TERMS & CONDITIONS

Please read this page carefully before completing the application form

1. UK Newspapers & magazines on sale to the general public:

- Cuttings (or photocopies) showing previous coverage of motor sport, plus an original letter on headed paper signed by the Editor undertaking to publish one or more reports from the meeting and stating when those report(s) will appear. The letter must confirm that each person will work on the report(s).
- If the publication was accredited for the British Grand Prix in the last three years, cuttings (or photocopies) must be supplied.
- The above requirements are only waived if the applicant holds a permanent media credential issued by the FIA for the 2010 Formula 1 World Championship.

2. UK Photographers:

A maximum of **12 photographer passes** are available for UK media. These are approved by the FIA. Priority will be given to photo agencies who are servicing a number of UK-based national and high-circulation publications.

3. UK Radio Stations:

The application must be supported by an original letter on headed paper, signed by the Station Manager or Director, undertaking to broadcast from Silverstone Circuit and stating when the reports will be broadcast. The letter must also confirm that all applicants will work on those reports. Passes are very limited, so your application may be unsuccessful, even if you comply with all conditions.

Public Relations Staff

You must supply an original letter signed by the holder of a valid MSA International Entrant Licence involved in a support race. This letter must confirm that each person will work for that team at the 2010 British Grand Prix meeting.

Free Newspapers

You must supply a letter and cuttings as specified at 1 and 2 on page 1.

Books & Artists

You must supply a letter from a publisher and examples of relevant published work.

Individual Acknowledgement**

Media passes for the press are issued by the Fédération Internationale de l'Automobile ("FIA") to certain organisations ("Accredited Parties") strictly subject to the terms of the FIA's Accreditation Agreement and Waiver of Liability (the "Accreditation Agreement"). Accredited Parties must identify the individuals who represent the Accredited Party at any particular event and be issued passes under the terms of the Accreditation Agreement ("Pass Holders"). All Accredited Parties and Pass Holders are asked to study the Accreditation Agreement and make the following acknowledgements.

I hereby acknowledge, by signing this form, that I have had the opportunity to read the detailed terms of the Accreditation Agreement and that I am bound by those terms. By signing this form I acknowledge that the Accreditation Agreement contains important terms that limit my rights. In addition, by signing this form I acknowledge that I have particular responsibilities and duties under the Accreditation Agreement.

I note that the Accreditation Agreement contains important terms dealing with, amongst other things;

- the limited liability of the FIA, the organisers, the promoters and a number of other organisations associated with the event in the case of accident, injury or death;
- the responsibility of the Accredited Party for all claims arising from its actions or the actions of the Pass Holders and the waiver in respect of certain future claims set out in the Accreditation Agreement;
- the strict prohibition on the taking of any moving picture images, sound recordings, use of trade marks, title or logos or the transmission of certain kinds of results as set out in the Accreditation Agreement;
- the requirement for me to follow all directions from all race officials and to stay within the areas for which I have been granted access.

However, I also note that the above merely paraphrases some (but not all) of the far more detailed and extensive legal provisions, limitations and waivers contained in the Accreditation Agreement itself and in the event of a conflict between the two, the Accreditation Agreement shall take precedence.
